11. To discuss, agree action and authorise any expenditure relating to electronic surveillance, as proposed by Cllr Wiseman.
12. To discuss, agree any action, and consider authorising £50 to Andrew Jones, to add a privacy notice on the Earswick Parish Council website contact page, as proposed by Cllr Bell.
13. To discuss, agree action and authorise any expenditure regarding the varnishing of two benches located around the pond, as proposed by Cllr Jones.

14. To ratify a complaint to the Monitoring Officer at City of York Council, raised by Earswick Parish Council, against Huntington Parish Councillor Dave Jobling, as proposed by Cllr Leveson.
15. To discuss, agree action and authorise any expenditure relating to the Parish Council's Emergency Plan, as proposed by Cllr O'Connor.
16. To discuss, agree action and consider authorising up to £30 in total to Mrs G Offler and/or Mrs J K Pace, to purchase plants/soil for the Earswick planters, as proposed by Cllr Jones.

To discuss, agree action and authorise any expenditure arising from a meeting of the Village Hall Committee, including consideration of the purchase of a separate lock for the larger of the two Village Hall gates, and a parking restriction sign to be placed at the entrance to the Village Hall, as proposed by Cllr Leveson.
