## 1. Apologies for absence

## 3. Minutes of Previous Meetings

The minutes for the Parish Council (PC) meeting held on the 12<sup>th</sup> July 2021, were approved as accurate records by the Councillors and signed.

4. <u>Dissolution of the Scented Garden Committee, return of the lease of the Scented Garden Committee and transfer of Scented Garden Committee funds to the Parish Council</u>

The PC received a letter from the Scented Garden Committee informing them of the dissolution of the Scented Garden Committee, return of the Scented Garden Lease, and intended transfer of any Scented Garden funds to the PC (to be used on Scented Garden (SG) expenditure). The PC accepted return of the lease and will take over the administration of the SG, with volunteers doing the gardening. The SG funds will be ring-fenced for SG expenditure.

The Parish Council approved one cut per month of the grass on the lower level of the SG, at £20 plus VAT per cut, to A Hill for August, September and October 2021, and April to October 2022.

The Parish Council approved £50 per treatment to R Warriner for treatment of the lawn in the Scented Garden, maximum of 2 treatments per year.

The PC recorded its very grateful thanks to Irene and David Jones, and all the SG Committee, for all their hard work on the SG.
