7. Planning Applications

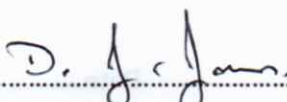
The Clerk used delegated powers to record views of the PC on the following planning applications:

- 26/00434/FUL - The Old Barn Moor Lane Earswick York YO32 9LL - Erection of 1no. dwelling following demolition of existing outbuilding. This was discussed and there were no objections
- 25/02547/FUL – various extensions to 70 Earswick Chase – the PC objected to this planning application.
- 25/01901/FUL – Land to the west of Strensall Road– the PC objected to this planning application.

The following planning applications were approved / refused by City of York Council:

- 25/02164/FUL - Hall Farm Strensall Road York YO32 9SW - part change of use of stables to 2no. storage units with associated external alteration – REFUSED

It was agreed to accept the quote for the picnic tables (£510) and the benches (£550). Cllr Lumley Holmes agreed to see if it's feasible for him to re-coat the other items. The clerk was asked to write to Domestic Chores to confirm arrangements. **Action BOC & Cllr Lumley Holmes**

13. Repair / Cleaning Out Of Centenary Wood Ditch

It was agreed to accept the quote for £1,200 to clean out the ditch in Centenary Wood. The clerk was asked to write to the contractor to accept the quote subject to them having an insurance certificate. **Action BOC**

14. Painting Metal Fence At Lock House Lane Car Park

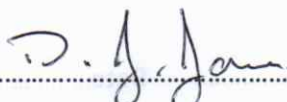
it was agreed to accept the quote for £995 to paint the metal fence at the Lock House Lane car park. **Action Cllr Jones**

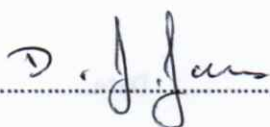
19. Items for information
